This privacy policy (this "Privacy Policy") is published to inform users of our Site of the personal data we will collect, use of collected data, who has access to the data collected, the rights of Site users and the Site's cookie policy.

### **1. Consent**

By using our Site users agree that they consent to:

- a. The conditions set out in this Privacy Policy; and
- b. The collection, use, and retention of the data listed in this Privacy Policy.

### **2. Personal Data We Collect**

We only collect data that helps us achieve the purpose set out in this Privacy Policy. We will not collect any additional data beyond the data listed below unless directly provided to us through contact forms that the user fills out.

### **3. Data Collected Automatically**

When you visit and use our Site, we may automatically collect and store the following information:

- a. IP address;
- b. Clicked links; and
- c. Content viewed.

### **4. Data Collected in a Non-Automatic Way**

We may also collect the following data when you affirmatively submit information on our Site:

- a. First and last name;
- b. Email address;
- c. Phone number;

### **5. How We Use Personal Data**

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or

indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for marketing purposes and the data we collect when the user affirmatively submits information on our Site may be used for communicating with that user.

## **6. Who We Share Personal Data With**

Employees - We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

Other Disclosures - We will not sell or share your data with other third parties, except in the following cases:

- a. If the law requires it;
- b. If it is required for any legal proceeding;
- c. To prove or protect our legal rights;
- d. To buyers or potential buyers of this company in the event that we seek to sell the company;
- e. Our translators require your data/files to complete translation requests.

## **7. How Long We Store Personal Data**
